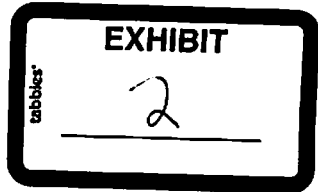

Handwriting characteristics appearing in Q-1 identified as the handwriting/signature of "Lawanna B. Clark" also appear in K-2 submitted as the known handwriting/signatures of "Yolanda B. Walker."


